Subject: Invitation to the Ninth Intergovernmental Session of the IOC Regional Committee for the Central Indian Ocean (IOCINDIO-IX), Dhaka, Bangladesh, 28–30 March 2023

I have the pleasure of inviting you to participate in the Ninth Intergovernmental Session of the IOC Regional Committee for the Central Indian Ocean (IOCINDIO-IX), to be generously hosted by the Government of Bangladesh from 28 to 30 March in Dhaka.

The session will bring together national competent governmental agencies, marine scientific communities and other relevant IOC stakeholders in the region, as well as the representatives from the IOC Regional Subsidiary Bodies with the view to foster regional and international dialogue, partnerships and cooperation, ocean science-policy interface, advance ocean science development, enhance technical and institutional capacities, and co-design ocean science solutions to critical challenges for sustainable development in the central Indian Ocean.

IOCINDIO-IX will comprehensively review the implementation of the Committee workplan since its last session in May 2021. The Committee will be updated on global ocean-related developments, including the United Nations Decade of Ocean Science for Sustainable Development (2021–2030), and will deliberate on its engagement in and contribution to the Ocean Decade, for example through the establishment of national Decade Committees. Special attention will be given to the progress review of the IOC open-ended intersessional Working Group on the Status of the IOC Regional Committee for the Central Indian Ocean (cf. IOC/A-31/3.5.6.Doc) in view of the transformation of the Committee into an IOC Sub-Commission, and to the supporting actions mobilized.

During the session, a **Senior Governmental and Regional Officials' Forum** chaired by the host country will be organised to express high-level commitments to the work of the IOC, the Ocean

An **IOCINDIO Youth Forum** is also planned during the Session with the view to foster involvement of students and early careers ocean scientists in the work of IOCINDIO and promote networking, mentoring and enhancement of national and regional capacity development. In order to achieve a full representation from the region, Member States are strongly encouraged to ensure the participation of their national youth associations and networks, notably students and early career scientists.

Taking into consideration the scientific and technical nature of the work of the IOC and the Committee, Member States and partners are strongly encouraged to ensure technical competencies and experiences required for their Delegations, also ensuring a gender balance.

In order to exchange views, receive advice from adjacent Sub-commissions and to foster interregional cooperation and co-design, their Officers and Technical Secretaries are cordially invited and strongly encouraged to attend the Session in Dhaka.

Please, kindly communicate in writing the names, positions, and contact addresses of the members of your delegations to me and Mr Justin Ahanhanzo (<u>i.ahanhanzo@unesco.org</u>) with copy to Ms Elena lasyreva (<u>e.iasyreva@unesco.org</u>) at your earliest convenience but <u>no later than 31</u> January 2023.

Relevant information and logistics arrangements for participants, will be forwarded to you via electronic means and will be posted on the <u>IOCINDIO-IX webpage</u> in due course. A copy of the Provisional Agenda is attached for your information as Annex 1. Given the extensive agenda of the session scheduled over three days only (tentatively including a half day for field study), I would like to kindly request Delegations to focus their interventions on the vision, guidance, and recommendations for concrete support actions to the IOC programmes, the implementation of the Ocean Decade in the region and the transformation of the Committee into an IOC Sub-commission. Member States and Observers are invited to submit a written national report on past activities by <u>14</u> March 2023 using the template attached in annex 2.

In connection with logistical arrangements, I am pleased to inform delegates that the Government of Bangladesh is graciously offering in-kind contributions for the organization of the session, including:

- Accommodation with breakfast and lunch to participants with a priority order given to representatives of Member States, the IOC Regional Sub-commissions, regional intergovernmental institutions, science networks and programmes in the Indian Ocean and Overseas partners, such as the IORA, PEMSA, IIOE-2, etc. (fifty–50) participants expected);
- (ii) Terminal pick up from the airport to the hotel and back;
- (iii) Local logistics.

At the IOCINDIO-IX Session, Member States will elect the Officers of the Committee, i.e., one Chairperson and two Vice-Chairpersons for the next 2-year intersessional period, April 2023-April 2025. Elected Officers may be re-elected for one additional term of office. Information about the election procedure and prescribed nomination forms are attached hereafter as Annex 3. Kindly note that nominations should be sent to me with a copy to Mr Justin Ahanhanzo, Acting Technical (j.ahanhanzo@unesco.org) Secretary of IOCINDIO at and Ms Elena lasyreva at (e.iasyreva@unesco.org), no later than 28 February 2023 at 18:00 p.m. (Paris time). As a reminder, be advised that the current IOCINDIO Officers are the following: Chair, Rear Admiral (retd) Khurshed Alam (Bangladesh), Vice Chairs Dr Maryam Ghaemi (Iran) and Dr Saif AlGhais (United Arab Emirates) serving their first term.

Election Procedures and Forms (deadline for submission: 28 February 2023)

As customary, at its Ninth Intergovernmental Session, the **IOC Regional Committee for the Central Indian Ocean (IOCINDIO-IX), Dhaka, Bangladesh, 28–30 March 2023,** shall elect one Chairperson and two Vice-Chairpersons, for the term April 2023–April 2025.

The Chairperson shall preside over the sessions of the Regional Committee and carry out the duties which are entrusted to him/her. The Vice-Chairpersons assist the Chairperson in his/her functions and substitute him/her where necessary. The Vice-chairpersons will be entrusted with specific responsibilities.

The Chairperson and the Vice-Chairpersons of an IOC Subsidiary Body shall not remain in his/her mandate for more than two successive terms, according to the IOC Rules of Procedure.

Nominations

Nominations of individuals to either the post of Chairperson or the posts of Vice-Chairpersons shall be submitted by Member States through the officially designated Head of Delegation to the IOCINDIO-IX or through the IOC Focal Point in the Member State or the Permanent Delegation to UNESCO.

Nominations shall be submitted in writing to the Executive Secretary using **Form A** (Chairperson) or **Form B** (Vice-chairperson). They must reach the Executive Secretary or his representative by the specified deadline for nomination (as indicated in the Circular Letter of IOCINDIO-IX).

Each nomination shall contain a declaration from the candidate that he/she is prepared to stand for the post for which he/she has been nominated and is willing to take on the obligations that would devolve upon him/her, should he/she be elected. Each nomination shall also contain a CV with the profile of the candidate (**Form C**).

Each candidate must be seconded by two Member States of IOCINDIO other than the nominating Member State.

Elections

The IOC general practice is working and deciding by consensus (Rule 38.2).

Should voting be necessary, decisions shall be made by a simple majority of the members present and voting (Rule 43.1), by secret ballot.
