Subject: Seventh Session of the IOC Sub-Commission for Africa and the Adjacent Island States (IOCAFRICA-VII), Nairobi, Kenya, 15–17 March 2023

On behalf of Prof. Kouadio Affian, IOCAFRICA Chairperson, I have the pleasure of inviting you to participate in the Seventh Session of the IOC Sub-Commission for Africa and the Adjacent Island States, which will be hosted at the United Nations Office at Nairobi, Kenya on 15–17 March 2023.

The session will bring together representatives of IOC Member States and organizations working in the fields of marine science and management of ocean and coastal resources and environment active in the region (IOC national focal persons/institutions, national, regional and international organizations). IOCAFRICA is a facilitator of regional and international cooperation towards the understanding and management of the African oceans and coastal ecosystems. The Sub-Commission aims at building conditions for ensuring sustainable development and safety of coastal populations in the region taking into account priorities expressed by Member States.

At its forthcoming session, Member States will review the implementation status of the current IOCAFRICA-VI workplan for 2021–2023 (Recommendation IOCAFRICA-VI.4). They will deliberate on priorities and activities to be implemented over the period 2023–2025, as well as develop the IOCAFRICA Strategic Plan for 2023–2029 in the context of both the African Union Decade of African Seas and Oceans (2015–2025) and the United Nations Decade for Ocean Sciences for Sustainable Development (2021–2030).

Member States are expected to propose firm national commitments to the programmes and activities developed under the aegis of the IOC in the region and to ensure that adequate resources and means are available to effectively implement them.

The election of the Officers of the Sub Commission (one Chairperson and three Vice-Chairpersons for a period of two years) will take place during this session. The current IOCAFRICA Officers, elected in 2021 have served for one intersessional period and are eligible for re-election. Relevant information and forms, the lists of geographical groups, and current IOCAFRICA Officers are attached. Candidatures accompanied by a CV must reach the IOCAFRICA secretariat not later than 15 March 2023 at the closure of business of the opening day. In this respect, I would like to encourage consultation and consensus within each geographical group and between geographical groups to take into account gender balance in the bureau of the sub-committee and to allow for election by acclamation.

I would like to take this opportunity of this letter to invite the Member States of the IOCAFRICA to:

- (ii) provide details of their national ocean programmes and plans. This should include an outline of one key issue that IOCAFRICA should address. Common activities will then be collated to form the basis of the IOCAFRICA workplan for 2023–2025, ensuring alignment thereof with national priorities and plans.

The above information should be submitted to Mika Odido by email <a href="m.odido@unesco.org">m.odido@unesco.org</a>, not later than 15 February 2023 to enable the secretariat to collate, translate and circulate summaries before the session.

The Provisional Agenda (document IOCAFRICA-VII/1 Prov.) for the session is annexed to this letter. Further information and documents will be made available online at the meeting website as soon as they are ready (<a href="https://on.unesco.org/iocafrica-7">https://on.unesco.org/iocafrica-7</a>). The working languages for the session will be English and French. The draft report will be prepared in English only during the session in view of its adoption by the Sub-commission. IOCAFRICA Officers will report on the session to the IOC Assembly at its 32<sup>nd</sup> session that is taking place next June at UNESCO/IOC Headquarters, Paris.

# ELECTIONS OF THE OFFICERS OF THE IOC SUB COMMISSION FOR AFRICA AND THE ADJACENT ISLAND STATES

#### **Nominations**

Nominations of individuals to either the post of Chairperson or the posts of Vice-chairpersons shall be submitted by Member States through the officially designated national coordinating body specified for liaison with the Commission (Rule 26.2), namely through the IOC Focal Point in the Member State or the Permanent Delegations to UNESCO.

Nominations shall be submitted in writing using Form A (Chairperson) or Form B (Vice-chairperson), and must reach the Nominations Committee not later than 17:30 on 15 March 2023.

Each nomination shall contain a declaration from the candidate that he/she is prepared to stand for the post for which has been nominated and is willing to take on the obligations that would devolve upon him/her, should he/she be elected.

Each candidate for chairperson must be seconded by two Member States of the IOC Sub-Commission for Africa and the Adjacent Island States, from different electoral groups than that of the nominating Member State. In the case of nominations for Vice-Chairperson, the two seconders should be of the same Electoral Group as that of the nominee's Member State.

#### **Elections**

Should voting be necessary, decisions shall be made by a simple majority of the valid votes cast (Technical arrangements 2.20(iv)), by secret ballot.
