**Subject: Announcement of the CARIBE WAVE 26 Tsunami Exercise  
 in the Caribbean and Adjacent Regions on 19 March 2026**

The Intergovernmental Coordination Group for the Tsunami and Other Coastal Hazards Warning System for the Caribbean and Adjacent Regions at its eighth session (ICG/CARIBE EWS-VIII, Port of Spain, Trinidad and Tobago, 29 April–1 May 2013), decided to conduct tsunami exercises named CARIBE WAVE on an annual basis leaving each Member State to define its level of participation.

At its 18th Session in May 2025, the ICG/CARIBE-EWS, recommended that Exercise CARIBE WAVE 26 should take place on **19 March 2026 at 15:00:00 UTC**. The following two hypothetical scenarios will be used:

- A tsunami generated by a magnitude 7.6 earthquake located along the Swan Island Fault for the Cayman Islands scenario.
- A tsunami generated by a tsunami generated by a flank landslide of the Kick-'em-Jenny submarine volcano.

For CARIBE WAVE 26, each Member State needs to select one scenario and complete the following survey ([https://www.surveymonkey.com/r/CW26\\_ScenarioSelection](https://www.surveymonkey.com/r/CW26_ScenarioSelection)) indicating its chosen scenario by **6 March 2026**.

The objectives of this exercise are three-fold: (1) exercise and evaluate communications between Regional Tsunami Service Providers and Member States/Territories; (2) evaluate the tsunami procedures and programmes within Member States/Territories; and (3) evaluate volcanic products. Regular exercising of response plans is critical to maintain readiness for an emergency. The CARIBE WAVE 26 exercise also supports the '[UN Ocean Decade Tsunami Programme](#)' goal that is to ensure that 100% of communities at risk from tsunamis are prepared and resilient to tsunamis and to implement the UNESCO-IOC [Tsunami Ready Recognition Programme](#). It is up to every country to decide at what scale to carry out the exercise.

As part of this exercise, the Pacific Tsunami Warning Center ([PTWC](#)) and the Central America Tsunami Advisory Center ([CATA](#)) will issue an initial dummy message on 19 March 2026 at 15:00 UTC and disseminate it on all their standard Tsunami Warning Centre broadcast channels. This dummy message will be issued to test communications with Tsunami Warning Focal Points (TWFPs) and National Tsunami Warning Centres (NTWC) and will launch the exercise. PTWC and CATA will then email the simulated tsunami products to officially designated TWFPs and NTWCs in accordance with the chosen scenario. Each TWFP/NTWC will decide whether and how to disseminate the messages within its area of responsibility. If a Member State does not inform the organizers of its chosen scenario selection, the organizers will make the selection.

The ICG/CARIBE-EWS of UNESCO-IOC, the US National Oceanic and Atmospheric Administration (NOAA), and the Caribbean regional emergency management stakeholders (CEPREDENAC, CDEMA, and EMIZA) are providing the framework for this exercise to enable emergency services throughout the Caribbean and adjacent regions to test and update their tsunami response plans. **The participant handbook** containing the details of the exercise will be available online at <http://caribewave.org>. Further information about the exercise will also be published on this link in due course.

For CARIBE WAVE 26, the ICG/CARIBE-EWS decided to continue to use TsunamiZone for registration (<http://tsunamizone.org/caribbean>). The participants will be able to sign up and see other participants. Emergency Management Organizations (EMOs) and exercise coordinators are encouraged to promote this registration system. For CARIBE WAVE 25, almost 500,000 participants registered via this platform.

Multi-lingual **online seminars** for orienting participants on the exercise in English, Spanish and French languages are scheduled for **20–22 January** and **24–26 February 2026**.
